
IT IS HEREBY AGREED AS FOLLOWS

AFIML's Responsibilities as Knowledge Partner (First Part)

1. Upon Agreement signoff, AIMS (A part of AFIML group) would be responsible for Student's registration and conducting the Competency test. Generating PPO, Evaluation of students, Deputation, and Placement.
2. AFIML / AIMS would conduct the proposed courses for the student through online/ offline mode.
3. AFIML/ AIMS would be responsible for Designing, Developing, Installing, and managing the respective Technology Infrastructure for acquisition through testing and consultation of students, and evaluation by faculty & industry experts, placements, and head-hunting bidding.
4. AFIML would place the Candidates with "Provisional Pre-Placement Offer Program and PPO would be released on the name of AFIML", which may be converted as final placement either with AFIML or different organization with same JOB OFFER. **Minimum offered CTC/Salary will be defer as per per the performance of the student.**

Responsibilities of APMC Institute (Second Part)

1. APMC partner would responsible for sourcing, counseling and recruitment of the candidate.



2. ACMC ensures to deliver of the first-party objective without getting any extra advantage in any manner.
3. ACMC partner needs to appoint one Counselor for his dedicated center.
4. ACMC partners have a minimum center space of 1000 sq.ft and basic amenities like PC and Internet.

Payment of Services & Invoicing

1. If a batch of students or individual student joins the course and pay either full fees or through education loan then ACMC partner will eligible to get the sourcing fees of Rs. 10,000 /- per candidate.
2. TDS and GST norms applicable as per Govt. policy.
3. ACMC will get the sourcing fees after 30 - 45 days if the candidate has completed 30 days in the program.

PERIOD OF SLA:

- 1) This MOU would be valid for the next 3 years (Three Years) commencing from the date of this agreement or as per the duration of the course.
- 2) This Agreement could be terminated by either party upon serving a notice of two months or any extension or addition to those services which is mutually agreed in writing

TERMINATION & DISPUTE SETTLEMENT:

1. It is hereby agreed that either the AFI Management Ltd. or The ACMC partner have the option at any time to terminate the Association by giving advance notice keeping the interest of ongoing courses and safeguarding the interest of the students, mutually agreeable notice period.



2. In case of any dispute or difference of opinion with regard to this agreement or the amendment done from time to time, the dispute would be referred to an arbitrator upon nomination by the parties to this agreement. An advocate or the person working in this capacity would be appointed as an arbitrator. However, the place of such arbitration proceedings would be in Pune.
